Division of Correction Directive

.01 Purpose.

This directive establishes policy and procedure for conducting grand jury tours and responding to grand jury reports.

.02 Scope.

This directive is applicable to each Division of Correction (DOC) facility.

.03 Policy.

- A. The <u>DOC</u> shall cooperate with grand juries in fulfilling their statutory obligation to annually tour State correctional facilities.
- B. The <u>DOC</u> shall provide written responses to all grand jury reports.

.04 Definitions.

.05 Procedures.

Division of Correction Directive: DOC.020.0011

Grand Jury Tours December 31, 2010

A. The managing official is responsible for:

- (1) Sending written notice of a scheduled grand jury to the <u>DOC</u> legal counsel at the office of the Department of Public Safety and Correctional Services with a copy to the <u>Commissioner</u> or a designee;
- (2) Notifying the grand jury before the scheduled tour of any new front entrance policy and procedures;
- (3) Meeting with the grand jury on the day of the tour;
- (4) Assuring that <u>an</u> inmate and <u>a staff member</u> on duty are available for interviews by the grand jury;
- (5) Assuring that the registration and search procedures required by directives DOC.110.0033 and DOC.195.0001 are carried out for each member of the grand jury;
- (6) Assuring that the grand jury has access to all areas of the facility;
- (7) Assuring that an escort, which provides proper protection is provided to the grand jury;
- (8) Assuring that the provisions of DOC.020.0012 are followed in responding to any grand jury request for inspection of inmate and <u>facility records</u>, or both;
- (9) Sending to the Commissioner <u>or a designee</u>, within three working days of receipt, a copy of any report received from a grand jury; and
- (10) Sending to the Commissioner <u>or a</u> designee, within ten working days of receipt, a draft response to any grand jury report which deals with the facility or the <u>DOC</u> generally.
- B. Within ten working days of receipt of the draft responses, the <u>C</u>ommissioner shall send a final response to the appropriate State's Attorney with copies to the secretary of the Department of the Public Safety and Correctional Services and the appropriate <u>managing official</u>.
