## .01 Purpose

Commissioner

- A. This directive establishes procedures for the handling of subpoenas for Division records.
- B. This directive establishes responsibility for the processing of subpoenas in compliance with all applicable laws and statutes.

## .02 Scope.

This directive applies to all Division staff

## .03 Policy.

Employees shall respond to subpoenas in a timely and thorough manner. Those who fail to adhere to this directive shall be subject to disciplinary action.

## .04 Definitions.

A. In this directive, the following terms have the meanings indicated.

## B. Terms Defined.

- (1) "Division records" means all archives and active files in the possession of the Division pertaining to official Division business, to include: emails, tapes, computer generated print-outs/reports, recordings, photographs, maps and all paper or electronically stored letters, memos, etc.
- (2) "Routine subpoena" means a command that does not request the production of a personnel file or compromise facility security.
- (3) "Subpoena" means a command to appear at a certain time and place to give testimony or to produce documents.

#### .05 Responsibility.

With regard to subpoenas for the production of Division records:

- A. Those subpoenas addressed to the DPDS Central Records Units, the Pretrial Release Services Program, or associated staff shall be processed in accordance with all:
  - (1)Applicable statutes and regulations; and
  - (2) Established standard operating procedures.

B Those subpoenas not governed by §.05 (A) of this directive shall be handled as followed:

- (1) The receiving employee shall be responsible to immediately inform the shift commander/supervisor of the subpoena;
- (2) The shift commander/supervisor shall be responsible to:
  - (a) Make a determination to either:
    - (i) Refer the subpoena to the Office of the Deputy Commissioner for a response as detailed in § .05 (B) (2) (b) of this directive; or
    - (ii) Instruct a knowledgeable and appropriately trained employee(s) to prepare records responsive to the subpoena as detailed in § .05 B (3) of this directive
  - (b) Ensure that each subpoena referred to the Office of the Deputy Commissioner:
    - (i) Is faxed/emailed to the Office of the Deputy Commissioner, along with a explanatory cover letter, (Appendix A) before the end of the shift on which the subpoena was initially received; and
  - (ii) The original subpoena, including, original envelope and the explanatory cover letter is immediately posted to the Office of the Deputy Commissioner via interdepartmental mail. During regular business hours, the shift commander/ supervisor may elect to immediately forward the original items through receipted hand delivery to the Office of the Deputy Commissioner.
- (3) The employee, assigned to respond to a subpoena, shall be responsible to:
  - (a) Locate and prepare an accurate and complete copy of all documents responsive to the subpoena;
  - (b) Complete a Statement of Authenticity, (Appendix B/C); and
  - (c) Prepare a packet to include:

DPDS.020.0001

- (i) The original subpoena and mailing envelope;
- (ii) A copy of all records responsive to the subpoena;
- (iii) An appropriate coversheet; and
- (iv) A completed Statement of Authenticity.
- (d) No less than five (5) workdays prior to the due date of the subpoena, hand deliver/ ensure the immediate hand delivery of the prepared packet to the Office of the Deputy Commissioner; and
- (e) When assistance is needed, consult in a timely manner with:
  - (i) The shift commander/supervisor; and
  - (ii) Staff assigned to the Office of the Deputy Commissioner.
- C. A subpoena for the production of personnel files or records which compromise the security of the Division shall be immediately referred to the Office of the Attorney General for a determination.
- D. Employees subpoenaed to give testimony in a case involving a claim against s State agency, official or employee shall follow procedures detailed in DPDS.020.0004, titled Service of Process.
