.01 Purpose.

The purpose of this directive is to rescind the Division of Pretrial Detention and Services (Division) directives that are no longer applicable to the Division administrative or operational responsibilities.

.02 Scope.

This directive is applicable to all units of the Division.

.03 Policy.

- **A.** The Division shall communicate current organizational policy and procedures to affected Division personnel.
- **B.** Division employees shall review Appendix A Division Rescissions of this directive to identify the policies that have replaced or superseded these rescinded directives.

.04 Definitions.

A. In this directive, the following terms have the meanings indicated.

B. Terms Defined.

- (1) "Division directive" means an official written communication issued by the Commissioner of the Division to set policy, establish guidelines, or provide information to promote the orderly and efficient administration of the Division.
- (2) "Managing official" has the meaning stated in Correctional Services Article, §1-101, Annotated Code of Maryland: 'Managing official means the administrator, director, warden, superintendent, sheriff, or other individual responsible for the management of a correctional facility.'

.05 Responsibilities.

- **A.** It is the policy of the Department of Public Safety and Correctional Services (Department) to conduct reviews of existing Division Directives and confirm the findings with a committee of Division and Department representatives. Based on this action, the Division Directives listed under *Division Rescissions* Appendix A are rescinded as of the date of this directive.
- **B.** The Executive Director of the Office of Grants, Policy, and Procurement, or a designee, shall maintain the directives listed under *Division Rescissions* Appendix A of this directive in accordance with the Office of the Secretary's Retention Schedule Number 2802.
- **C.** The managing official shall ensure facility directives are updated or rescinded in accordance with this notice.
