**SUB: INMATE PERSONAL PROPERTY/ALLOWABLE ELECTRONIC ITEMS**

Effective immediately, the following restrictions apply to allowable electronic devices:

**X-Box 360 and PlayStation 2** – can only be purchased from Walkenhorst, Game Dude and Estarland with Wi-Fi capability disconnected.

**NOTE:** Inmates order these items at the risk of having the warranty voided.

**PlayStation 2** must have controllers with cords (wireless controllers are unauthorized).

**MP3 Players** – (Walkenhorst only) Please be advised that the MP3 Player model #38428-918 has been discontinued. The new model is #38428-915. It still comes with pre-loaded music and a charger. (See attachment for MP3 Player and Charger).

USB cords/cables are deemed as contraband with the exception of the X Box 360 controller cord which only attaches to the console and the controllers (see attached photo). All other such cords/cables are to be confiscated.

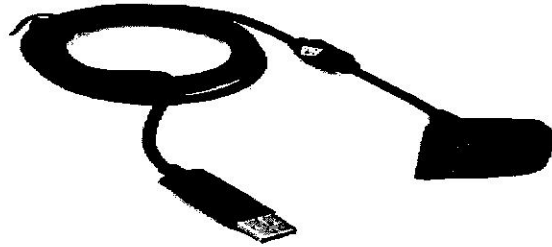
An inmate found in possession of a USB cord/cable shall be charged with possession of contraband and have his/her electronic devices confiscated and sent home at his/her expense. They shall also lose the privilege to possess any of the above items indefinitely.

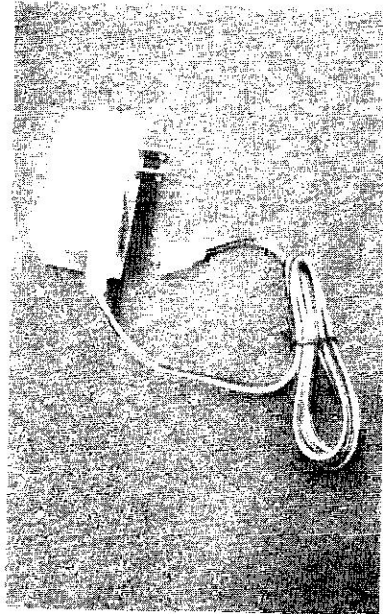
